CONDITIONS

1) If it becomes necessary, in the judgment of the Director and the Camp Health Supervisor, to use outside hospitalization, medical, surgical or dental aid or any other healthcare provider for the health and well being of the camper, I hereby authorize the Camp Director to use such outside aid, which shall be billed to me or my insurance. Hilltop is authorized to use its own judgment for immediate handling of any situation and act as summer guardian for my child. Hilltop will attempt to contact the parent prior to any emergency treatment. The New York State Department of Health requires your child's prescription and over-the- counter medications (including vitamins) to be pre-packaged and sealed by dose by a pharmacy. Parent(s) and/or quardian(s) are responsible for providing the adequate quantities of daily medications in this manner. NYSDOH requires a doctor's order for all medications to be dispensed by our medical staff. 2) Photos & videos taken during the camp season of my child may be used for promotion. If you oppose this policy, please forward a written note stating your rejection. 3) Camp Hilltop's name, logo, written materials, slogans or variations thereof, photographs or images taken at Camp Hilltop or from Camp Hilltop's website may not be used for any purpose. 4) The camp has the right to dismiss any camper who exhibits emotional, psychological or behavioral conditions that are disruptive to the camp program or that are harmful to him/herself or the well-being of other campers or staff. Under these circumstances, no refund will be given. 5) I understand that part of the camping experience involves activities, group living arrangements and interactions that may be new to my child. New experiences come with certain risks and uncertainties beyond what my child may be used to dealing with at home. I am aware of these risks, and I am assuming them on behalf of my child. I realize that no environment is risk-free and so I have instructed my child on the importance of abiding by the camp's rules including that they must remain supervised at all times. My child and I both agree that s/he is familiar with these rules and will obey them. 6) I agree that any dispute concerning, relating, arising out of or referring to the subject matter of this contract shall be resolved exclusively by binding arbitration in New York State and Delaware County, according to the then existing commercial rules of the American Arbitration Association and the substantive laws of that state. 7) While we wish that we could control every possible risk, and while we will use our best efforts to keep your child safe from viruses, pathogens and communicable diseases, we want to make clear that we cannot promise or guarantee that viruses, pathogens and communicable diseases will not enter camp. and that by the very nature of the personal interaction that takes place in the camp environment, there is always a risk of your child becoming ill with a communicable disease. We want you to be fully aware of this risk in making the decision to send your child to camp this summer, and that you are willing to assume and accept it on your child's behalf. 8) Because we want to do everything to keep camp operating in a safe manner, if your child is exhibiting symptoms of or tests positive for a communicable disease, they may be guarantined as recommended by our medical staff. Depending upon the medical advice we receive from federal and state health officials, your child may be allowed to remain at camp while under guarantine, or you may be required to make immediate arrangements to pick up your child. We understand the hardship this could present, but we want to do all we can to assure the safety of both your child and the rest of the camp population. 9) Camp Hilltop is not a peanut or tree nut free camp. Our camp food service is not gluten free. Please contact us regarding any special diets.

PAYMENT SCHEDULE

 Registrations received on or after December 1, 2022 but before February 1, 2023 are required to pay \$1,500
 at the time of registration.

 Registrations received on or after February 1, 2023 but before May 1, 2023 are required to pay \$2,000
 at the time of registration.
- Registrations received on or after May 1, 2023 are required to pay the full amount at the time of registration.

If the above terms are not met, all discounts are null and void. In addition, all fees and the child's place in camp may be forfeited.

LATE PAYMENT FINANCE CHARGES which equals a monthly rate of 1.5% of the unpaid balance will be added. If an overdue account must be referred to the camp's attorney for collection, the parent or guardian of the camper will be required to pay all attorney's fees.

DISCOUNTS Siblings - 10% discount will be deducted from sibling's camp fee.

Referral - Any family referring a new camper to Hilltop will be eligible for a credit of 5% of that camper's fee, credited to their account. Check/Cash – A 3% discount will be applied at the time of final payment toward the tuition if all payments are paid by check/cash.

CHANGES IN SESSION DATES OR REDUCTION IN LENGTH OF STAY AFTER MARCH 1, 2023 WILL RESULT IN LOSS OF ANY DISCOUNTS AND A PENALTY OF \$250 WILL BE ASSESSED. AFTER JUNE 1ST A SESSION REDUCTION WILL RESULT IN LOSS OF ANY DISCOUNTS AND A PENALTY OF ONE-HALF THE PRORATED TUITION.

REFUND OF PAYMENTS: The refund policy is not administered on an individual basis. This policy must be followed by every customer, without exception. Refunds are not contingent upon the reason behind the request. Up until March 1, 2023, payments are refundable minus a \$250 administrative fee. A cancellation made after March 1, 2023 will receive no refund. We make no allowances for campers arriving late. If a camper should leave camp before the end of their enrolled session the camp shall apply one-half of the prorated camp tuition toward next year's fee, with noted exceptions. There will be no refund due to illness or if a child needs to be removed from camp due to emotional, psychological or behavioral conditions that are disruptive to themself and/or the camp community. There will be no refunds of camp store, trip charges, optional horse program, cabin photo, transportation fees and/or any other fees for extra services.

OPTIONAL FEES: Before each camper arrives at camp the camp forms will be available through www.Hilltop.campintouch.com. This includes optional services and trips that you may choose to sign up for. These include: transportation on selected dates, camp store, camp photo, optional horse program, lice treatment, speciality diets and the special trip program.

SPECIAL NOTE: Camp Hilltop cannot accept the application of children who do not have the promise of living cooperatively with other children. If there is anything you should share, please explain on a separate sheet of paper and attach or email it with the application. It is imperative to your campers wellbeing that you inform us now of any significant behavioral concerns or special circumstances involving physical or psychological considerations your child may have, along with a treatment plan, if your child has one, so we can work to implement the parts that are relevant to the camp setting.

PROCESSING OF APPLICATION: The undersigned acknowledges that s/he is the parent or legal guardian of the camper and has full authority to enroll the child with Camp Hilltop. Supplying the credit card information and signing this agreement gives the camp permission to apply camp charges to the card listed below. The appropriate deposit based on the terms above is required to process this application and reserve the desired session.
